Felony Adult Drug Court Consultant - DATE Fund Approval

Troup County Felony Adult Drug Court is requesting the use of DATE funds to finance a two day consult with Kenneth Arnold, Senior Director of Court & Community Services, River Region Human Services, Inc. Mr. Arnold serves as a faculty presenter for the National Drug Court Institute and has been working with Felony Adult Drug Courts for over 25 years. The budget for the consult with Mr. Arnold is as follows:

Accountability Court Supplemental Grant Awards

In October, the DUI/Drug Court and the Family Dependency Treatment Court submitted an application for supplemental funding to the Criminal Justice Coordinating Council (Board approval was obtained). Both Courts were successful in securing supplemental funding as follows:

DUI/Drug Court:

DUI/Drug Court received a total supplemental award of \$11,400 to be used as follows:

Surveillance (home checks of Court participants):	\$3,600
Drug Testing	7,800

Family Dependency Treatment Court:

Family Dependency Treatment Court received a total supplemental award of \$15,000. The entirety of this award is to go toward funding substance abuse treatment services for Court participants.

We ask for approval of these supplemental awards. Furthermore, we request for approval of a budget amendment to reflect these changes.

FINANCIAL IMPACT:

Both supplemental awards change budgeted revenues and expenses for the DUI/Drug Court and the Family Dependency Treatment Court. We are requesting a budget amendments to reflect these changes.

Reimbursement Resolution-SPLOST

Resolution will permit expenditures approved in the SPLOST V Intergovernmental Agreement. The purpose is to replace security equipment that has been determined to be non-repairable.

REIMBURSEMENT RESOLUTION

(Resolution No.: _____)

WHEREAS, Troup County, Georgia has an immediate need and opportunity to make certain purchases and expenditures for projects to be funded by the imposition of a Special Purpose Local Option Sales Tax (“SPLOST V”) which was approved by the voters of Troup County and which would begin to be collected after January 1, 2019; and

WHEREAS, Troup County wishes to establish a procedure through which general fund of the county could be used for SPLOST V projects and be reimbursed in full once SPLOST V revenues are received by the County from the Georgia Department of Revenue and distributed as set forth in the Intergovernmental Agreement for the Use and Distribution of Proceeds from Troup County SPLOST V;

NOW, THEREFORE, BE IT RESOLVED, that the Troup County Manager be and hereby is authorized to immediately use and expend sums from the general fund for authorized SPLOST V projects, including, but not limited to, replacement of security systems, under the following terms and conditions:

- 1) All sums borrowed from the general fund shall be spent only for authorized SPLOST V projects;
- 2) The general fund shall be fully reimbursed from SPLOST V proceeds as soon as practicable and in no event later than the expiration of the SPLOST V collection period;
- 3) The Troup County Clerk shall maintain a complete record and accounting of

borrowing from the general fund and expenditures for SPLOST V projects as required by O.C.G.A. §48-8-121(a)(2) and §48-8-122;

- 4) In making expenditures pursuant to this Resolution, the County Manager and purchasing director shall not be limited by the spending cap set forth in Section 2-105 of the Troup County Code. However, in addition to the record keeping, annual report and audit requirements of O.C.G.A. §48-8-121(a)(2) and §48-8-122, the County Manager and County Clerk shall on at least a bi-annual basis report to the Board of Commissioners the amount of borrowing from the general fund to date, the SPLOST V projects for which the borrowed funds were expended, and an estimate of when the general fund will be reimbursed in full through the collection of SPLOST V proceeds.

Below are two options to replace the failed Identification System.

Currently there are 2 different access control systems running the Government Center Building. The older system was installed when the building was built and is no longer being manufactured in its current state. The newer system runs about half the doors and the server is large enough to handle the remaining doors on the old systems (ATS sized it initially to handle the entire county if desired).

Option 1 – Migrate all existing doors to the existing S2 Access Control system which handles the cameras and panic alarms. **\$93,954.23 Q23939**

Pros –

- County Personnel could use single badge from all County locations (Jail,Gvt Center)
- Total integration into existing system running new doors at Gvt.
- County could add doors to any building and administer from single point (Jail or Gvt Center or Both)
- Badging and New Printer included

Cons –

- Price (But best long term)

Option 2 - Migrate only failed ID portion of existing system to existing access Control Panel leaving physical doors operating. (Staff would still enter info into 2 systems) **\$3,431.77 Q24035**

Pros –

- Price

Cons –

- About half the Physical doors still on old system
